A LOCAL LAW TO AMEND
SECTION 220-3.B OF THE CODE OF
THE VILLAGE OF BRIARCLIFF
MANOR AND THE ZONING MAP
ADOPTED THEREUNDER TO
PROVIDE FOR A DIGITIZED MAP
AND CORRECTION OF RESULTANT
INNACURACIES OF CERTAIN
ZONING DISTRICT BOUNDARIES

Be it enacted by the Village Board of Trustees of the Village of Briarcliff Manor, as follows:

Section 1. Zoning Map. The Zoning Map of the Village of Briarcliff Manor, New York, dated October 29, 1958, last revised on December 17, 2009, which accompanies and is made a part of Chapter 220 of the Village Code pursuant to Village Code Section 220-3.B is hereby replaced with a digitized Zoning Map dated October 19, 2011, which was prepared relative to the creation of the R80A District in 2009 and the B1A District in 2011, together with the desire to add a Village Zoning District layer to the Village's Geographical Information Systems (GIS) Database. As a result of the GIS layering, inconsistencies were determined as to certain zoning district boundaries as they relate to some 22 tax parcels in the Village which will be corrected on the said Zoning Map.

Section 2. Village Code Text. Village Code Section 220-3.B is hereby amended by repealing it in its entirety and replacing it with the following:

"B. Map. The boundaries of such districts are hereby established as shown on the map entitled "Zoning Map, Village of Briarcliff Manor, New York, dated October 29, 1958," which has been digitized and last revised on October 19, 2011, which map accompanies and is hereby made a part of this chapter. Such map replaces in its entirety the Zoning Map of June 1953 as heretofore amended from time to time."

Section 3. Severability. The invalidity of any word, section, clause, paragraph, sentence, part, or provision of this local law shall not affect the validity of any part of this local law which can be given effect without such valid part or parts.

Section 4. Effective Date. This local law shall take effect upon the later of its filing in the Office of the Secretary of State of New York within the provisions of the Municipal Home Rule Law.
