## MANAGER'S REPORT

The New York State Department of Transportation is currently constructing the *flyover* or *Ramp X* project immediately adjacent to the Village. DOT also has completed plans on the repaving and new line striping of Route 9, from Geneva Road in the Village of Ossining to Route 117 in Mount Pleasant.

### The flyover or Ramp X project, will provide a direct connection from Route 9A, southbound to Taconic State Parkway, southbound

Quick and important facts about the project:

- The project area is located in the Town of Mt. Pleasant
- The on-ramp will begin just south of the boundary of Briarcliff Manor
- It will parallel the northbound connection of the Taconic State Parkway to Route 9A
- A significant retaining wall will be constructed adjacent to Beech Hill Road
- The North County Trailway will be moved in a westerly direction adjacent to the retaining wall
- The anticipated completion date for the project is November 2007

### The repaving and new line striping of Route 9, from Geneva Road in the Village of Ossining to just north of the Route 117 intersection

Quick and important facts about the project:

- It will create one lane in each direction, with a middle third lane to be used for left turns
- At the hill by Regua Street, located in the unincorporated portion of the Town of Mount Pleasant, there will be two lanes heading northbound to accommodate the speed of trucks climbing the hill
- The Scarborough Road, Scarborough Station Road, Marlborough Road and Revolutionary Road Route 9 intersections will remain four lanes (two in each direction), in order to handle the traffic
- The project will be awarded in November 2006 and per the DOT contract the work must be completed by November 2007
- Once the project is awarded, the Village will be informed of the actual time frames for completion of the project and those dates will be shared with you in a future Manor Monthly
