IMPORTANT EMERGENCY MANAGEMENT DATABASE FOR SPECIAL NEEDS POPULATION


As part of Village emergency management, we are in the process of developing a comprehensive database of our special needs population. This crucial database will be shared with Westchester County for Emergency Management purposes. The Village needs your help to make sure that the database is accurate and complete. People who are considered to have a special need, who may require additional assistance during a disaster or emergency, fall into any of the following categories:

- have one or a combination of disabilities: physical, visual, auditory, and cognitive;
- live in a residence for the elderly or in a nursing home;
- are a hospice patient;
- may be non-English speaking (in some cases).

Generally, those who are *non-ambulatory*, *rely on dialysis*, *use oxygen and/or a nebulizer*, would be classified as special needs persons

IMPORTANT SAFETY TIPS OFFERED BY THE POLICE DEPARTMENT

Police Chief Norman R. Campion states that, “currently hundreds of children are walking to and from school and school buses – many for the first time. It is unfortunate, but important to note that more than at any other time of the year children have an increased risk of being hit by a motor vehicle when going back-to-school.”

Chief Campion highlights the following tips, which are offered by the American Automobile Association (AAA), to help protect your children. Children should:

- Look all ways before crossing the street
- Cross only at corners and marked intersections
- Obey Police Officers, School Crossing Guards, Members of AAA School Safety Patrols, and Traffic Signals
- Watch for turning motor vehicles
- Be especially alert in bad weather
- Not play near traffic

Most importantly, Chief Campion says, “drivers must remember to be especially careful of youngsters during this busy time.”

COMING SOON: NATURAL HAZARDS PREPAREDNESS QUESTIONNAIRE will arrive in resident mailboxes on Wednesday, September 20, 2006. The Village is in the process of creating an **All Hazards Mitigation Plan** that will help the Village: 1) develop strategies to mitigate natural hazards damage (natural hazards include: hurricanes, tornadoes, heavy rain event, etc.); 2) coordinate activities to reduce the risk of injury or property damage that can occur during a natural hazard event; and 3) maintain and update the Village infrastructure when necessary by obtaining funds from the State and Federal Governments. The Questionnaire is a vital instrument, that will help create a complete plan, please be sure to fill it out and send it back to the Village.
