### BOARD OF TRUSTEES UPDATE

At the March 6<sup>th</sup> Board of Trustees meeting it was announced that our Village Manager, Michael Blau, will be leaving the Village and assuming the position of Village Administrator in Tarrytown. Mr. Blau's last day as Village Manager will be April 11, 2008.

Mr. Blau has been with the Village for six and one half years and has been responsible for the day-to-day operations of the Village. He has also been deeply involved in the numerous projects that we have undertaken to improve our Village and to provide many municipal services. With his expertise and knowledge he has provided valuable guidance, advice and information to the Board of Trustees as we tackled the many issues that the Village has and will continue to face.

It has been a privilege for the Board of Trustees as well as the Village to have had Mike as our Village Manager. On behalf of the entire Village the Board of Trustees wants to thank Mike for his services and offer him the best of wishes for continued success in his career.

The Board of Trustees will immediately start the search process for a new Village Manager and anticipate the process to take several months. The Board of Trustees is committed to continuing to provide quality service in a fiscally sound manner to all our Villagers. Part of that commitment is to seek out the best qualified person to be our Village Manager and continue to manage daily Village functions.

Ingrid Richards who is currently our Assistant Village Manager will be appointed as the Interim Village Manager. We believe Ingrid will competently manage day-to-day Village operations during this interim period. Ms. Richards has already communicated her intent to apply to the Board of Trustees for the full time position as the Village Manager and will be considered amongst other potential candidates.
